

Why Petplan?

What will my policy cover?

First time cover is available for dogs and cats from 8 weeks and before their 8th Birthday (5th birthday for Select Breeds). 100% of vet fees (less fixed excess and non claimable items, unless Pet%Share option is selected, then 75% of vet fee).
